

# OCCUPATIONAL SAFETY, HEALTH AND ENVIRONMENTAL MANAGEMENT COURSE (OSHEMAC) FOR 2023

#### **OUR MISSION STATEMENT**

Our mission is to conduct Occupational Safety and Health training in order to create ideal work environments and a healthy workforce.

#### **OUR TRAINING VISION**

To be the center of excellence in occupational safety and health training, and information dissemination and development.

#### **OUR TRAINING OBJECTIVE**

To provide workers, employers, public and OSH community with the capacity to prevent occupational diseases and injuries through effective training and information sharing.

#### **Course Length**

We are currently offering OSHEMAC by virtual distance learning, and it runs over 8 weeks each part. At the end of Part 1, students sit for a 3-hour examination which should be passed to proceed to the next level, Part 2. In between the two parts students conduct an industrial research project as partial fulfillment of the course. Upon successfully completing the course, students are awarded with transcripts and certificates.

This is an interactive and participative course involving group work, a factory visit (when operating normally), case studies and presentations. The course is tailor made to equip the students with skills, knowledge and attitudes to manage safety and health effectively.

#### **Entry requirements**

The course is open to management personnel, technical staff, health professionals, and trainee safety and health officers. Academic requirements are 5 Ordinary levels inclusive of English language and Science. Further to that, a relevant professional Qualification will be required.

- 4. The course will be offered online, therefore you need to ensure that you have adequate data to attend lectures 2 full days per week on Microsoft Teams as well as to download documents that will be sent to your email or WhatsApp. You will also submit your assignments using email.
- 5. Only examinations will be physical
- 6. After submitting your application, you will receive an offer letter if your application is successful

USD\$350 for Part I and USD\$350 for Part II (equivalent at prevailing bank rate). Please note that the fees are subject to change without notice

#### **Course dates**

OSHEMAC is offered twice a year i.e during the first and second half of the year respectively. Intake 1 part I February to April. Part II will be in May. Intake 2 part I July/ August and part II October.
